Am I Subject to this subpart?	I. This subpart applies to: (A) Affected facilities that are part of a process unit that produces any of the chemicals listed in 40 CFR 60.707 as product, co-product, by-product, or intermediate, and that commence construction, modification, or reconstruction after June 29, 1990, and on or before April 25, 2023 (B) Affected facilities: (1) Reactor processes that do not discharge their vent stream into a recovery system; (2) The combination of a reactor process and the recovery system into which it discharges its vent stream; (3) Combinations of two or more reactor processes and the common recovery system into which their vent streams are discharged II. Not subject to this subpart: (A) Any reactor process designed and operated as a batch operation; (B) Any reactor process operating as part of a process unit that produces beverage alcohols;

	(C) Any reactor process that does not use, contain, or produce any VOC; (D) Any reactor process that is subject to NSPS DDD; (E) Affected facilities with a total resource effectiveness (TRE) index value greater than 8.0; (F) Affected facilities in a process unit with a total design capacity for all chemicals produced within that unit of less than 1 gigagram per year (1,100 tons per year); (G) Affected facilities operated with a vent stream flow rate less than 0.011 scm/min; (H) Affected facilities with vent streams that are routed to a distillation unit subject to NSPS NNN, with no other releases to the air except for a pressure relief valve; (I) Affected facilities operating with a concentration of total organic compounds (less methane and ethane) in the vent stream of less than 300 ppmv as measured by Method 18; or concentrations of TOC in the vent stream of less than 150 ppmv as measured by Method 25A
