



DRINKING WATER STATE REVOLVING LOAN FUND PROGRAM CATEGORICAL EXCLUSION

In accordance with the Nebraska Drinking Water State Revolving Fund environmental review process, which is based on the National Environmental Policy Act, an environmental review has been performed on the proposed agency action below:

The City of North Platte has applied for funding, through the Drinking Water State Revolving Fund (DWSRF) program administered by the DWEE to investigate approximately 5,500 service lines of unknown material and to replace approximately 2,400 known lead or galvanized service lines. The overall financial need for the City of North Platte is assessed in the Preliminary Engineering Report for Lead Service Line Replacement and reflects an amount of \$22,000,000. The current DWSRF offer reflects the eligible financial timeframe; however, additional funds could be made available to meet the needs of the community.

This project was listed on the Planning List of projects in the State Fiscal Year 2026 Intended Use Plan (IUP) and ranked with 15 priority points. Based on supporting documentation on file with the DWEE, this project was determined to be eligible for a 40-year loan at an interest rate of 0.0%. In addition, the administrative fee will be assessed at 0.0%. North Platte is eligible for up to 60% DWSRF loan forgiveness and a 10% mechanical inventory grant. The current residential water rate for a service connection is \$17.95 per month with an additional usage charge of \$1.56 for the first 1,000 gallons used, \$1.45 for the second 1,000 gallons used, \$1.34 for the third 1,000 gallons used, \$1.23 for the fourth 1,000 gallons used, and \$1.12 for each 1,000 gallons used in excess. This brings the monthly household water cost to \$24.65 per month for a typical 5,000 gallon per month household water usage. The typical long-term annual DWSRF Debt Service (including 10% coverage) is \$90,750. Based on 9,643 total active service connections, residential water rates may need to be raised approximately \$0.78 per month to address the new debt service.

The proposed project was reviewed for eligibility for a categorical exclusion from National Environmental Policy Act review specified in 40 CFR (Code of Federal Regulations) Part 6.204. The project meets all criteria described in the above reference and the Department has determined that this project is eligible for a categorical exclusion. Consequently, a preliminary decision has been made that a Finding of No Significant Impact will not be prepared. The project as proposed is solely directed toward lead service line replacement. Justification for categorical exclusion includes:

- The proposed action is not known or expected to have potentially significant environmental impacts on the quality of the human environment either individually or cumulatively over time;
- The proposed action is not known or expected to significantly affect federally listed or state listed threatened or endangered species or their critical habitat;
- The proposed action is not known or expected to significantly affect national natural landmarks or any property with nationally significant historic, architectural, prehistoric archeological or cultural value, including but not limited to, properties listed on or eligible for the National Register of Historic Places;
- The proposed action is not known or expected to significantly affect environmentally important natural resource areas as wetlands, prime farmland, wild and scenic rivers, and significant fish or wildlife habitat;
- Based on a review of the available mapping, a portion of the project may lie within the 100-year floodplain, but none of the work will be a new disturbance;
- The proposed action is not known or expected to have a significant effect on the pattern and type of land use (industrial, commercial, agricultural, recreational, residential) or growth and distribution of population including altering the character of existing residential areas, or may not be consistent with state or local government, or federally-recognized Indian tribe approved land use plans or federal land management plans;
- Based on review there are no new/relocated surface or groundwater discharges; the project is not being developed to provide capacity to service a population greater than 30% of that existing for the community; it is not primarily needed for future growth and is supported by a State growthy strategy; and
- The proposed action is not known or expected to cause significant public controversy.

The City has a permit to operate a public water system under the provisions of the Nebraska Safe Drinking Water Act and the Regulations Governing Public Water Supply Systems, Title 179. The proposed project is determined by the DWEE to help the public water system maintain compliance with the Safe Drinking Water Act. The system last underwent a routine sanitary survey by the DWEE in January of 2024, wherein two significant deficiencies and one minor deficiency were noted, which have since been addressed. This action completed the Technical, Managerial, and Financial, (TMF) program policy. North Platte will still be required to undergo an Initial, and if necessary, a Final TMF Assessment by the DWEE, to ensure that their capabilities meet the requirements of the Safe Drinking Water Act. Also, their current Environmental Tracking Tool score is 0, which is below the allowable 11 per issued U.S. Environmental Protection Agency guidance.

The DWEE shall revoke the categorical exclusion and shall require a full environmental review if, subsequent to the granting of exclusion, the state determines that the proposed project no longer meets the requirements for a categorical exclusion due to changes in the proposed project, or new evidence reveals that serious local or environmental issues exist, or federal, state, local or tribal laws are being violated.

This action is taken on the basis of careful review of the application and other supporting data, which are on file in the office of the DWEE. These are available for public review upon request. 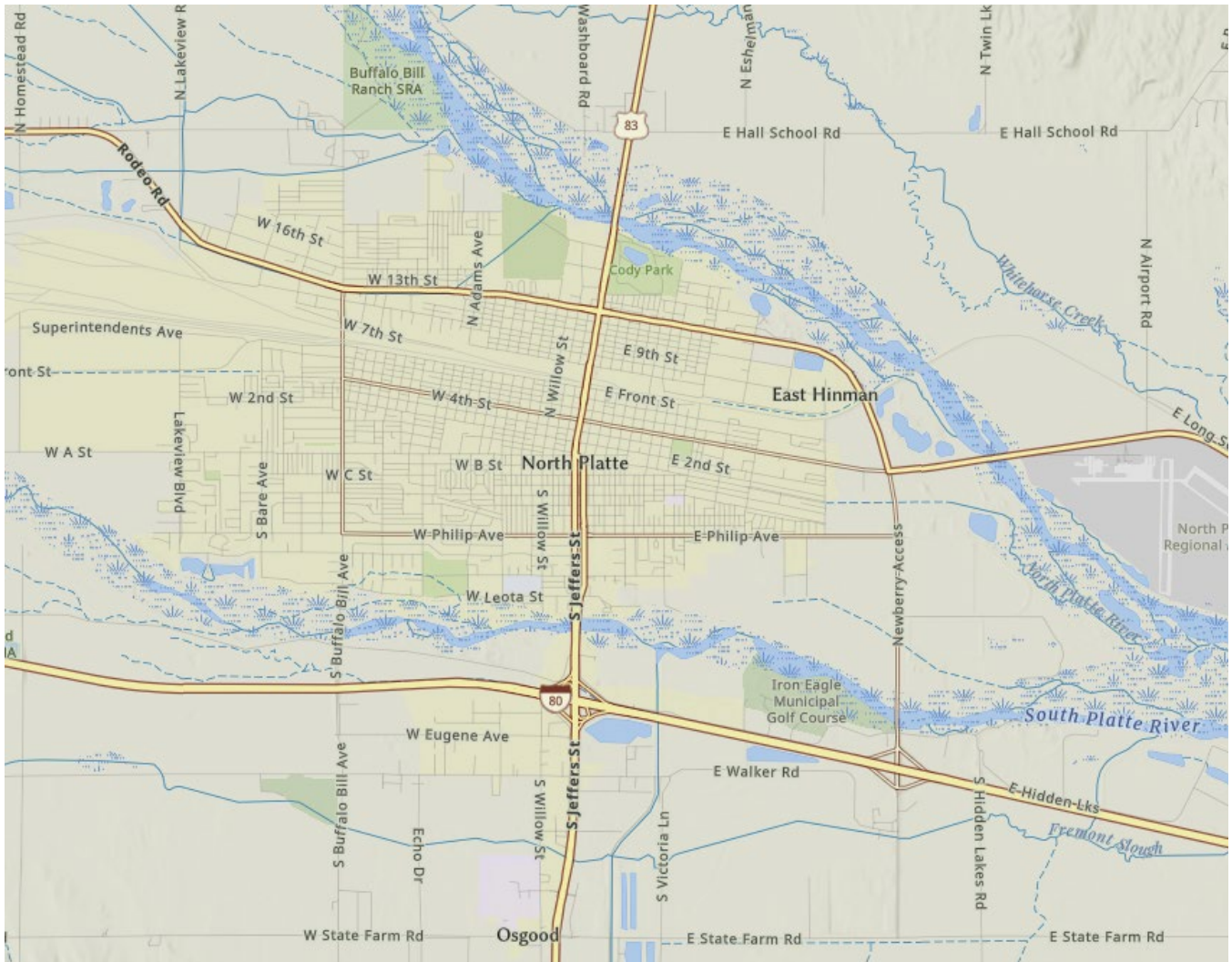


Figure 1: Map of the City of North Platte (from nebraskamap.gov)
