This form is part of a loan application to finance energy efficiency improvements to the property listed above. The Nebraska Department of Water, Energy, and Environment requires legal release of all utility and fuel use information for properties where financed improvements are located, for the purpose of determining the effectiveness of those improvements in reducing energy use and cost. This form is only used when the person seeking financing to install energy improvements to the property is not the same person who is responsible for the accounts of one or more utilities or fuel suppliers serving the property.

**BORROWER.** Print or type your name and mailing address in the space provided and identify the property for which the loan is being sought. If applicable, mark the street address of the property including city and zip

code. Otherwise, mark the complete legal description of the property to be improved. Give this form to the person responsible for the utilities or fuel services to this property (**CUSTOMER**). If different utilities are in different persons' names, provide one of these forms for each customer. Attach the completed forms to your loan application.

**CUSTOMER.** Mark the name, mailing address, telephone number and your account number for the electric utility and each fuel supplier serving this address for which you are responsible. If the only energy source for the building is electricity, check the box provided. Sign and date the signature block in the space provided and type or print your name, telephone number and mailing address on the next lines. Return the completed form to the **BORROWER**.
