Notes: Diesel fuel includes all combustible liquids suitable for use in diesel–powered motor vehicles. It does not include kerosene. The *Diesel Fuel Tax Act* replaced the *Special Fuels Tax Act* and became effective on July 1, 1994, so there are no numbers before July 1, 1994. NA indicates data is not available.
