ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-8769A

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Water, Energy, and Environment (Department) show that surface water appropriation A-8769A is held by **Lynn R. and Amy K. Selting**.
2. Appropriation A-8769A with a priority date of **August 23, 1956**, authorizes the use of water for irrigation of the **20.7 acres** of land described below. The water may be diverted from **Cedar Creek** at points of diversion located on both banks of the stream in the **NE¹/₄NE¹/₄** of **Section 03, Township 23 North, Range 06 West of the 6th P.M. in Antelope County**. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every **70 acres** irrigated at a maximum combined rate of **0.30 cfs** from all points of diversion.

3. The Department has received information concerning the use of surface water appropriation A-8769A that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On February 24, 2026, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-8769A. The Notice was delivered by certified mail to Lynn R. and Amy K. Selting, 83984 526 Avenue, Elgin, Nebraska 68636; and Jerry and Sue Wilgocki, 34392 Highway 30, Columbus, Nebraska 68601.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.
6. The Department has determined that appropriation A-8769A has not been used for its required purpose for more than five consecutive years.
7. Nebraska Revised Statutes § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.

ORDER

IT IS HEREBY ORDERED appropriation A-8769A is **CANCELLED**.
